Question: You allude to fixing housing issues for members inside and outside the bargaining process.

Elizabeth: experience in information organization and storage including sensitive information. As a very detail oriented person, file management and being in touch with the other members of the executive.

Abigail: currently a Grad Student advisor in SGPS we deal with student and academic appeals with faculties. My background in law school was in civil and labour law.

Lizzie: What is your experience working as a treasurer or in finance?

Brittainy – I have a certificate in business and experience running the finances and books for small businesses

Mia Akbar – Took accounting and management in high school. Worked on client accounts and billing

Jamie Grove – Handled student data at Laurentian, and data analytics such as supply and demand in energy Ontario

Seamus – Physics: Given the future outlook for the economy and potential future decline in membership dues, what actions will you take to prepare the budget for this situation?

Mia Akbar – I know we have quite a bit of reserve funding in 901 budget, I seek to run a progressive budget. The 2022-2023 ran a small deficit to support steward work. I plan to do the same in order to strengthen the stewards

Brittainy Bonnis – the new Treasurer will work with the budget that we pass today. We do have a healthy reserve. I don't expect hiring levels to change drastically. I push for spending money on our membership such as paying Stewards.

Jamie Grove – We want to make sure we have liquidity for bargaining next year which I would take into account for any motions brought forward in the fall. I would be carrying the deficit into the next year until we are beyond the negotiation period. I don't expect changes in membership trends.

Lizzie: How comfortable are you with the grievance process and sharing the role with the Steward for grievances?

Nina: I am very willing to learn about this and to work with the grievance steward depending on their willingness to share the role as well. I have had some informal experience.

Seamus: What kind of activities would you like to do that are new or would like to improve?

Nina: Beefing up orientation activities and awareness about PSAC rights and responsibilities. Beefing up the capacity for stewards organizing. More events that are focused more on accessibility but maybe not formal meetings just informal gatherings.

Jake Morrow - History: Not every department on campus has a steward, what are your strategies for increasing the reach of the stewards council.

Nina: One way is to look at how departments are already interacting and to reach out to the stewards themselves to strategize by department to raise awareness. Attending other events to maintain visibility, etc.

Milka Njoroge – Gender Studies: What strategies would you use to recruit more nonwhite students and international students to the union?

Nina: Consulting and listening to those who have this positionality in the union. I motivate an idea of listening and validating concerns which is something I understand is infrequent in a university environment.

Maximillian – considering all aspects of an issues, critical analysis, debate, critical thinking and considering all information on the question of equity

Nina – what are some action items or goals you would want to achieve in the next year and how to achieve those goals?

Maximillian – evaluate and re-evaluate the trainings that we are currently given at Queen's. Otherwise make myself accessible and make my contact information completely available. Given any grievance, I want to make myself aware of all policies to be in the best position possible to do the job.

Qazi – With the tuition abolition movement, it seems the authorities might get us to meet in the middle. As equity officer I want to make sure that with the other members that actions continue to bring international students under the umbrella

of all actions – ie. Abolish tuition. Also organizing more wider hybrid events so more historically underrepresented students can find a voice.

Elizabeth Cameron – Sociology: What do you plan to champion for post-docs? Armineh – my foremost goal is to raise the salaries of post-docs and you can see many gaps between postdocs and faculty. And also another challenge is healthcare services – unfortunately due to the agreement with the government they cut funds for mutual care. So if you don't have a family doctor you don't have full service from medical clinics. Additionally a key challenge is housing as there are no housing opportunities offered by Queen's currently.

Lizzie Bygott – Chemical Engingeering: A big complaint from postdocs is that they don't feel part of the community and they want to be involved – what would you do for this? Armineh – we did a survey that showed postdocs are interested in more social

events, out of university events, to gather as part of the Queen's community and in their own post-doc community.

Discussion:

Lizzie – question on the investment income from our budget

Harsha – we made a decision to invest our reserve funds and first checked in with Regional and CRA that we were allowed to create an investment for three years

Seamus – what is our current surplus if we are planning to run a deficit this year as well as last year.

Harsha - I assume you are talking about the reserve (yes) – so first of all we balanced our budget last year rather than actually running a deficit on our budget. Discussion moves in-camera.

Levi – Biology – Is there any discussion to increase the size of the strike fund? Is this something that needs to be addressed with PSAC regional?

Harsha – this has to go through our by-laws so I would identify this as a budget priority for our by-laws to discuss our caps on strike funds. Moves in-camera. Brittainy – in camera.

Levi – Biology – Are there any changes in the membership dues in this budget? Harsha – the way we predict income is that we make the assumption that our number of members will not change so we index our percentage of dues to the changing rate of income

Elizabeth – what is the role of the budget and finance committee in making decisions on the budget?

Harsha – decisions on the budget tend to occur around budget and finance committees but these decisions can begin and happen out side of those meetings as well and you can watch for announcements in this regard in the coming year.
